TRS Benefit Enhancements SB 10 Legislation Final Approval by 88th Legislature 5/28/2023

One-time Stipend to Certain Retirees:

- Provides a \$7,500 stipend to eligible retirees that are 75 years of age and older (approximately 186,000 annuitants)
- Also provides for a \$2,400 stipend to eligible retirees between the ages of 70 to 74 (approximately 104,000 annuitants)

COLA to Certain Retirees:

- Provides a 2% cost-of-living adjustment to eligible retirees with a retirement date between September 1, 2013 through August 31, 2020 (COLA impacts approximately150,000 annuitants)
- Provides a 4% cost-of-living adjustment to eligible retirees with a retirement date between September 1, 2001 through August 31, 2013 (COLA impacts approximately 195,000 annuitants)
- Provides a 6% cost-of-living adjustment to eligible retirees with a retirement date on and before August 31, 2001 (COLA impacts approximately 75,000 annuitants)

Funding:

The TRS Pension Fund will not be impacted. The Legislature has appropriated nearly **\$5 billion** to pay for these benefit enhancements in total from state funds. Approved funding is <u>more</u> than what was originally proposed in both the Senate and House plans.

- o Stipend: \$1.636 billion
- o COLA: \$3.354 billion

Expected Timeline:

- The stipend is expected to be paid to eligible retirees in September of this year.
- The COLA is contingent upon approval by the voters this upcoming November, and the COLA would take effect January 1, 2024.
